Guidelines on the level of fines



- Pursuant to the preparatory works, fines should be set in accordance with the following guidelines:
- 1. The gravity of the infringement
 - Less serious infringements: up to DKK 400.000 (EUR 55.000)
 - Serious infringements: DKK 400.000 DKK 15 million (EUR 2 million)
 - Very serious infringements: DKK 15 million and above
- 2. The duration of the infringement
 - Short infringements: less than 1 year
 - Medium-length infringements: 1-5 years
 - Long termed infringements: 5 years and above (increase of up to 10 %)
- 3. The annual turnover of the entity


- Court imposed fines- individuals
 - The Public Prosecutor has advocated fines on individuals based on the individual's gross salary
 - Courts appear to reject salary based fines
 - DKK 15.000 (flat fee)?
- Settlement individuals
 - End of salary based settlements?
 - DKK 25.000 (flat fee)?

Statutory maximum: 10% of total global turnover in last business year

- Car Glass (2008 art. 81): Ca. **EUR 1,384 mio.**

Fines under the 2006 Guidelines (2)



- 66 fines in 15 decisions 8 companies received immunity
- Largest fine to a single company: Intel (2009 art. 82): EUR 1,060 million.
- Smallest fine to a single company: Mozer in International Removal Services (2008 art. 81): EUR 1,500
- Total amount of fines in the 15 decisions: Ca. EUR 5,507 million.
- Average fine: Ca. EUR 83.4 million
- 35 of the 66 fines have been appealed to the CFI (in relation to 5 fines, the deadline for appealing the decision has not expired). No judgment yet in any of the appeals.



Limit reached?



• Hitting the ceiling...

 At least 8 fines have been capped at the statutory maximum of 10% of total global sales

First company fined into bankruptcy?

- European cartel fines questioned
- Increasingly tough penalties imposed by European competition regulators on cartel offenders were thrown into the spotlight on Friday when one of the largest chemicals manufacturers in Slovakia filed for protection from its creditors just weeks after being slapped with a €19.5m (\$28.7m) fine by the European Commission... (Financial Times, 19 September 2009)
- Calcium Carbide cartel
- Inability to pay is a ground for reducing a fine
